*Article XI, Section 3 of Board Bylaws . . . By no later than June 30, before the annual election, a nominating committee of no fewer than five (5) REALTOR Members shall be appointed by the President with the approval of the Board of Directors. The Immediate Past President shall serve as Chairman, and if the Immediate Past President cannot serve, the President will appoint the Chairman. At least four (4) remaining members of the committee shall consist of one (1) active past President and two (2) active REALTOR Members, plus one (1) current Director. The Nominating Committee shall select one candidate for each office and one candidate for each position to be filled on the Board of Directors. The report of the Nominating Committee shall be made by publication in the Board's newsletter/magazine/membership communiqué at least thirty (30) days preceding the election. Additional candidates for the offices to be filled may be placed in nomination by petition signed by at least twenty percent (20%) of the REALTOR® Members. The petition shall be filed with the Chief Executive Officer at least fifteen (15) days before the election. The Association Executive shall send specific notice of each additional nomination to REALTOR Members before election.*
